IRS updates procedures to become a certified professional employer

organization: IRS [Revenue Procedure 2023-18](#) addresses how to apply to be a certified professional employer organization, the requirements for a CPEO to remain certified and the procedures relating to suspension and revocation of CPEO certification. This new guidance modifies and supersedes Revenue Procedures 2016-33 and 2017-14.

Prepare now for new Form 1099-K reporting threshold: A new reporting threshold for Form 1099-K, Payment Card and Third-Party Network Transactions, began in tax year 2023. Encourage your clients to keep good records now for the next filing season. Find more information at [IRS.gov/1099k](#)
